## SIMPLE CREMATION PACKAGE - \$ 694.00

This package includes the basic services of the funeral director and staff, transfer of the body from the place of death within **King**, **Pierce**, **Snohomish**, or **Clark** county to a refrigerated holding facility and to a crematory facility with use of a positive identification system, filing of the death certificate, the actual process of cremation with cardboard alternative container, plastic utility urn, disposition of the cremated remains by common scattering at sea or delivery to person designated within the Authorization for Cremation and Disposition (within the county of death).

### ITEMIZED SELECTIONS

Washington Cremation Society only provides direct cremation services (without embalming or viewing) and disposition of the cremated remains. The good and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic service and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.
