- This contract is entered into between the 'Contract Partner', whose details appear in the Contract Partner section and **Your Maldives – Your Travels**, hereafter referred as the 'Operator', whose details appear in the Operator section.
- All rates are quoted in US Dollars, per person per night on Full board Diving basis and Full Charters as mentioned.
- **All rates are net rates, non-commissionable and are subjected to Government Bed Tax USD 8.00 / Night / Person and T-GST [6% till DEC 31, 2012 and 8% from JAN 1, 2013]**
- Check-in is at 10:00hrs and Check-out is at 08:00hrs. Early check-in can be guaranteed where an additional room night has been booked one night prior to arrival date. Late check-out is subject to availability and can only be guaranteed where an additional room night has been booked at the time of reservation.
- All reservation and cancellations must be confirmed from the Operator's reservation department in writing by email. Reservation should be sent via reservations@yourmaldives.mv. To ensure proper delivery of services to the clients, all reservation details must be clearly marked on all rooming lists/booking request/ Final confirmation.
- Operator agrees to provide the services mentioned on this contract as per mentioned.
- The Operator shall invoice the contract partner on the basis of the services mentioned in the booking.
- If a query is not raised within 48 hours of presentation of invoice, the invoice will be deemed to have approved as presented as correct.
- All payments to be made to above mentioned bank account or any details advised on writing by Operator. All remittances are on the face value of the invoice and all bank charges are to be absorbed by the contract partner. Once the Contract Partner has made the payment, bank remittance advise must be email to reservations@yourmaldives.mv
- The Rates agreed upon are valid to the booking requests received from the office of the contract partner mentioned in the contract overleaf.
- The contract partner agrees to the cancellation policy mentioned overleaf.
- Any additional services (extra, excursion etc.) rendered by the Property or Operator which have not been indicated in the booking confirmation and those which are not part of this Contract, must be settled directly between the Property or Operator and the guest before departures of the guest from the boat.
- The Operator must be informed in writing at least 45 (forty five) days prior to the effective date of any change of ownership or management of the Contract Partner.
- Either party can request for a termination of the contract by giving the other party 45 (forty five) days written notice. In such a situation, Operator agrees to honor all the future confirmed bookings of the contract partner that would have been confirmed by the Operator, provided the contract partner to settle the value of the future bookings immediately (earlier than the effective date of termination of contract or as per the payments, Cancellation & Refund Policy)
- Any additional services (extras, meals etc.) rendered by the liveaboard which have not been indicated in the time of reservation and those which are not part of this Contract, must be settled directly between the liveaboard and the guest before the departure of the guest from the Liveaboard
- In the event of termination of this contract, the Contract Partner agrees to pay the Operator all outstanding dues for the services rendered to the clients as per the final booking confirmation received by the Contract Partner. The obligation of this contract shall be rendered invalid in all circumstances of force majeure such as, but not limited to, civil unrest, war and war like conditions, strikes, natural catastrophes, epidemics, acts of terrorism and government ordered measures of closure and restraint that jeopardizes the ability of either party to perform its duties. In such events the Maavahi, Your Maldives Liveaboard and the Contract Partner shall work together to keep the loss to both parties as low as possible.
