Check whether the tutor has a direct experience in working at bachelor education centers with the Ministry of Education. Find if the teacher is an active member of financial training organizations such as the Educational Research Association of Singapore.

Efficient study system

You need to check whether the facility delivers individual attention even in [economics group tuition](#). Collective studying is highly effective with the supervision of a good coordinator. The student and parent reports should help you in understanding tutor skills. However, you should call up the facility for a direct discussion. You must be able to talk with the teacher at a convenient appointment. Discuss your concerns. Explain the different aspects of quality education you expect. You may also elaborate on the individual qualities of your son/daughter. This helps the teacher in providing unique attention to all.

Verify the infrastructure at the facility. You may want to inquire on the availability of mailed/downloaded notes. Many students prefer individual studying to the collective approach. You cannot force one to engage in a system not of preference. An annoyed mind cannot concentrate on the studies. Many candidates prefer to prepare in private. Call the facility in enquiring. Check if they can provide module-oriented notes or a distant education system. Remote study centers should also arrange for online tests to ensure proper education. Discuss whether the facility is available.
