## BPI Europe is covered by FSCS - - - There are some changes!

As a UK-licensed bank, BPI Europe is covered by the Financial Services Compensation Scheme (FSCS). The FSCS protects most depositors, including individuals and small companies, up to £75,000 from 01 January 2016. Eligible deposits of large companies and small local authorities, which have not previously been protected, are now eligible for FSCS protection from 03 July 2015 onwards. Any deposits you hold above the limit are unlikely to be covered. Please ask your BPI Europe PIc branch of account or visit www.fscs.org.uk for further information.
