Please provide proposed detailed elevations, to a scale of 1:20 or 1:50, showing the proposed sign. This plan needs to show the style of the sign, its dimensions, the font and size of any lettering and the colour scheme.

Please provide a proposed full elevation, to a scale of 1:100, showing the sign in relation to the building, this should show the exact positioning of the sign and it's height above ground level.

Please provide an amended 1:500 site plan which clearly details the parking spaces referred to in section 10 of your application form. Please also amend this drawing to include an annotation detailing to which elevation the proposed signage will be affixed.

Please amend the red edge on the submitted site location plan to include the access from the site to the public highway. Prior to the submission of this plan please annotate the drawing to include Anne Reed Road and the Beverley Beck.
