# **OVERVIEW AND GOALS**

# **SCOPE OF SERVICES**

## **Initial Setup**

## **REVIEWING SEO AUDIT**

• We'll start by having a kick-off meeting to review the audit and get your feedback on where we plan to focus our efforts so we all know we're on the same page starting out.

## **SETTING UP TOOLS**

- We'll make sure your analytics tools are set up properly and configure Google Analytics and Google Webmaster Tools to measure what traffic is contributing to your sales conversion.
- We use other valuable tools like <u>Ahrefs</u> that provide information on where your links are coming from, competitive analysis, keyword research tools, brand monitoring, and more.

#### **ONPAGE OPTIMIZATION**

 Based on the audit, we'll execute any necessary changes to your site which may include things like content edits, changing the title and meta description, updating your robots.txt and XML sitemap, using 301 redirects, and making usability tweaks to the design.

## **Ongoing Services:**

#### **LANDING PAGES**

• Landing pages help you rank for targeted keywords and we'll help you develop them. Instead of one page trying to rank for multiple keywords, it's better to create a separate page for every keyword you want to target. The page should contain valuable, in-depth content that's way better than your competitors. The more useful and comprehensive your landing page, the higher Google will place in their search rankings.

#### **LINK BUILDING**

This is where we engage with people to receive links. The goal is to get high quality vs. high volume links as Google penalizes sites that have too many low quality links. How will we do this?

- **Engaging influencers** associated with your brand, commenting on their blog articles, sharing their social media posts, and eventually sending them emails requesting links.
- Publishing high-quality, content and getting interaction through social media.
- **Engaging and contributing to forums**, groups, and other more targeted communities that are likely to share and blog about your content.

 Reaching out to the press and relevant bloggers for media coverage, interviews, and product reviews.

## **Measurement and Optimization**

- We'll review Google Analytics and other metrics tools to make sure we're staying on track with our goals.
- We'll perform ongoing keyword research and analyze your place in them.
- We'll uncover where you should be ranking and what traffic will drive the most revenue.
- We'll alter your website accordingly by building pages and content to rank for the most valuable keywords.
- We'll provide call tracking information so that you can see how many calls you are getting from organic searches (non paid), and Google Adwords (PPC) if you choose that option.

## **1.0 Services Rendered**

## **MARKETING CONSULTATION**

We'll meet with you once each month, create strategy documents, and offer email and phone consultation. We'll review your analytics and provide recommendations.

#### **CONTENT DEVELOPMENT**

We'll develop a content strategy for your blogging and write/publish blog posts on a monthly basis, both on your site and on other websites related to your location and/or industry.

## **SEO CONSULTING & MAINTENANCE**

We'll monitor your website for search performance, write content and meta tags, and review backlinks.

## **SOCIAL MEDIA CONSULTING & MANAGEMENT**

We provide social media updates as needed with this plan.

We'll offer support relating to your Wordpress website. We don't offer hosting, so you'll need to host your website with another company who will handle downtime or email issues relating to your hosting account.

## **CHANGES AND REVISIONS**

## 2.0 Mutual Cooperation

## 3.0 Charges for Services Performed

3.1 Requests above and beyond our monthly budget may be considered out-of-scope and an amendment to the budget will be recommended. Projects that go dormant for longer than 45 days will incur fee to resume work at the discretion of Titan Web Agency.

## **4.0 Terms of Payment**

## **4.1 BILLING SCHEDULE**

We're sure you understand how important it is as a small business that you pay the invoices that we send you promptly. We're also sure you'll want to maintain a positive working relationship and keep the project moving forward, so you agree to stick tight to the following payment schedule.

Titan Web Agency will invoice Melinda Harr Dental for the start up fee and prorated online marketing services should a monthly plan be chosen. Once paid, work will start. Should you choose the local listing optimization plan, we will charge you 1/2 up front and 1/2 when completed.

Melinda Harr Dental will supply Titan Web Agency with all necessary purchase order numbers and other internal information required for invoice processing before the close of the month of work (if applicable).

## **4.3 CLIENT AGREEMENT TO PAY**

You agree to pay our initial (1st) invoice upon receipt which will act as a deposit for the project. Every invoice after that will have 10 day payment terms. In the event payment is not made within 10 days, Titan Web Agency will charge a late payment fee of 1% per month on any overdue and unpaid balance not in dispute, to cover the manpower, interest, and other costs Titan Web Agency pays for carrying overdue invoices from Melinda Harr Dental. In addition, Titan Web Agency reserves the right to stop work until payment is received.

#### 4.4 COLLECTION COSTS

In the event that we incur legal fees, costs and disbursements in an effort to collect our invoices, in addition to interest on the unpaid balance, you agree to reimburse us for these expenses.

## **5.0 Cancellation of Plans**

You have the right to modify, reject, cancel or stop any and all plans or work in process. However, you agree to reimburse us for all costs and expenses we incurred prior to your change in instructions, and which relate to non-cancelable commitments, and to defend, indemnify and hold us harmless for any liability relating to such action. We agree to use our best efforts to minimize such costs and expenses.

# 6.0 Responsibilities of Titan Web Agency and Melinda Harr Dental

## 6.1 TITAN WEB AGENCY'S RESPONSIBILITY FOR RELEASES

We shall obtain releases, licenses, permits or other authorization to use testimonials, copyrighted materials, photographs, art work or any other property or rights belonging to third parties obtained by us for use in performing services for you (If applicable).

## **6.2 CLIENT RESPONSIBILITY FOR RELEASES**

You guarantee that all elements of text, images, or other artwork you provide are either owned by your good selves, or that you have permission to use them.

Then when your final payment has cleared, copyright will be automatically assigned as follows:

You'll own the visual elements that we create for this project. We'll give you source files and finished files and you should keep them somewhere safe as we're not required to keep a copy. You own all elements of text, images and data you provided, unless someone else owns them.

We'll own the unique combination of these elements that constitutes a complete design and we'll license that to you, exclusively and in perpetuity for this project only, unless we agree otherwise. We can provide a separate estimate for that.

## **6.3 CLIENT RESPONSIBILITY FOR ACCURACY**

You shall be responsible for the accuracy, completeness and propriety of information concerning your products and services which you furnish to us verbally or in writing in connection with the performance of this Agreement.

## 7.0 Confidentiality

Titan Web Agency acknowledges its responsibility, both during and after the term of its appointment, to use all reasonable efforts to preserve the confidentiality of any proprietary or confidential information or data developed by Titan Web Agency on behalf of Melinda Harr Dental or disclosed by Melinda Harr Dental to Titan Web Agency.

## 8.0 Term and Termination

## 8.1 PERIOD OF AGREEMENT AND NOTICE OF TERMINATION

This Agreement shall become effective as of the date signed and shall continue until terminated by either party upon not less than 30 days' notice in writing given by either party to the other.

## **8.2 TERMINATION FOR CAUSE**

Either party to this Agreement may terminate the Agreement if the other party defaults in the performance of any of its material duties and obligations and the default is not cured within thirty (30) days of the receipt of notice of said default, or if the default is not reasonably curable within said period of time, unless the defaulting party commences cure within said period of time and diligently proceeds to cure the default.

In addition, either party may immediately terminate this Agreement by giving written notice to the other party if the other party is insolvent or has a petition brought by or against it under the insolvency laws of any jurisdiction, if the other party makes an assignment for the benefit of creditors, if a trustee, or similar agent is appointed with respect to any property or business of the other party, or in the case of the Client, if the Client materially breaches its obligations to make payment pursuant to this Agreement.

## **8.3 PAYMENT FOR NON-CANCELABLE MATERIALS?**

Any non-cancelable materials, services, etc., we have properly committed ourselves to purchase for your account, (either specifically or as part of a plan such as modules, photography and/or external services) shall be paid for by you, in accordance with the provisions of this Agreement. #### **8.4 MATERIALS UNPAID FOR**

If upon termination there exist any materials furnished by us or any services performed by us for which you have not paid us in full, until such time as you have paid us in full you agree not to use any such materials, in whole or in part, or the product of such services.

#### **8.5 TRANSFER OF MATERIALS**

Upon termination of this agreement, provided that there is no outstanding indebtedness then owing by Melinda Harr Dental to Titan Web Agency, Titan Web Agency shall transfer, assign and make available to Melinda Harr Dental all property and materials in its possession or control belonging to Melinda Harr Dental. Melinda Harr Dental agrees to pay for all costs associated with the transfer of materials.

## 9.0 General Provisions

## 9.1 GOVERNING LAW

This Agreement shall be governed and construed in accordance with the laws of the state of Utah.

## **9.2 REPRESENTATIONS AND WARRANTIES**

The parties each individually represent and warrant that each has full power and authority to enter into this Agreement and to perform all of their obligations hereunder without violating the legal or equitable rights of any third party.

## **9.3 ENTIRE AGREEMENT**

Except as otherwise set forth or referred to in this Agreement, this Agreement constitutes the sole and entire Agreement and understanding between the parties hereto as to the subject matter hereof, and supersedes all prior discussions, agreements and understandings of every kind and nature between them as to such subject matter.

## 9.4 SEVERABILITY

If any provision of this Agreement is held to be illegal, invalid, or unenforceable under any present or future law, then that provision will be fully severable.
