#### Condition 2.7 - Records

A Private Hire Operator shall keep records to include the details shown below of every booking and shall produce the original of such records on request to an authorised Officer for inspection. These records should be kept for a minimum of 1 year.

#### Condition 2.5 - Responsibility for Drivers & Vehicles

An operator must ensure that all vehicles and drivers operating under his/her operator's licence are complying with the legislation and conditions relating to private hire vehicles and drivers.

#### Condition 2.4 - Change of address or details of Licence

The proprietor shall inform the Licensing Enforcement Officer of the name and address including any future changes of address of all licensed drivers engaged by him/her and of any such driver ceasing to be so engaged within seven days of the date of the appointment or termination as the case may be.
