Terms & Conditions

MEMBERSHIP FEES: The membership fees must be paid monthly in advance on the first day of each month. In respect of any broken period a pro-rata adjustment shall be

BILLING & SECURITY DEPOSIT: Credit card or direct debit billing is a requirement of membership. The Member irrevocably authorises Base Virtual Offices to deduct all amounts charged to the Member by Base Virtual Offices on such credit card / direct debit account at any time during any billing period. Base Virtual Offices reserves the right to require a security deposit and agrees to notify the Member of such a requirement in advance. Should a security deposit be required, refund of security deposit shall be made on request to the Member 5 days after the termination of the Agreement. The security deposit shall not be deemed as advance payment however Base Virtual Offices is entitled to deduct from the security deposit any monies owed to Base Virtual Offices for services provided. Such deduction shall not be deemed to waive any breach by the Member of this Agreement, Base Virtual Offices shall have the right to pursue the Member for monies owed under this agreement, including but not limited to forwarding the Member's contact information to legal advisors, collection agencies and credit reporting bodies, which may result in listing a default against the Member and/or Guarantor where applicable.

COSTS: The Member will be responsible for Base Virtual Offices reasonable costs in recovering any monies owed under this Service agreement.

TERMINATION: After your initial contract period, you will be on a month to month contract. You may terminate the contract anytime after the end of your initial contract period. Notice to terminate must be received in writing with one months' notice. Receipt of termination notification and the termination date will be confirmed in writing by Base Virtual Offices. Only once this confirmation has taken place will outstanding fees be confirmed. Base Virtual Offices reserves the right to terminate this agreement immediately in the event that its team members are being harassed by the Member or persons attempting to contact the Member. Should Base Virtual Offices have reason to suspect immoral, unethical, illegal or fraudulent business practice it reserves the right to immediately terminate this agreement and all services being provided and to notify

the appropriate authorities without notice.
