**CONDITIONS**

1. Taxpayer shall promptly pay for the corresponding Mayor's Permit, Health Certificate and Sanitary Permit Fees as well as the Municipal Licenses and/or taxes as they become due as mandated by Puerto Galera Municipal Revised Revenue Code 2010;
2. Taxpayer shall post the Mayor's Permit, Sanitary Health Certificate and official receipts covering the above payment to a conspicuous place in my store, office or any other place where my business, trade occupation, or calling is conducted or carried on;
3. Taxpayer shall hang and keep at my office, store or establishment at all times the Book of Account or other pertinent records necessary in the operation of my business/es or trade /s conducted.
4. Taxpayer shall renew this permit within the first 20 days of January every year thereafter and until such time this permit is revoked or voluntarily surrendered; and
5. Taxpayer shall comply with the existing pertinent ordinances, laws, rules and regulations and those which hereafter shall be promulgated by duly constituted authorities.
6. Taxpayer shall be cooperative with the cleanliness program of the Municipal Government of Puerto Galera, Oriental Mindoro.

PERMIT SHALL BE SUBJECT TO IMMEDIATE CANCELLATION UPON FAILURE OF GRANTEE TO CONTINUOUSLY COMPLY WITH THE PROVISIONS OF THE BUILDING CODE OF THE PHILIPPINES, ENVIRONMENTAL LAW OF THE PHILIPPINES, TOURISM CODE OF THE PHILIPPINES, SANITATION CODE OF PUERTO GALERA AND OTHER PERTINENT LAWS, RULES AND REGULATIONS REQUIRED FOR THE ISSUANCE OF PERMITS AND LICENSE.
