When an account is opened it will have the same BN, and you will be able to use this number when dealing with these offices.

**IMPORTANT:** if you had already been issued a Business Number by CRA and the first nine (9) digits are different than what is on this letter, then please contact CRA at 1-800-959-5525 from 8:15 a.m. to 8:00 p.m., Monday through Friday, excluding Statutory Holidays.

Personal information provided on the Statement of Registration is collected, used and disclosed under the authority of the Freedom of Information and Protection of Privacy Act (FOIPPA) and the Partnership Act for the purpose of assessment.
