NOW THIS TRUST DEED WITNESSETH AS FOLLOWS:

1. **TRUST:**

The Settler doth hereby grant, transfer and assign unto the Trustees the sum of **Rs.10,000/- (Rupees Ten thousand only)** and TO HAVE AND TO HOLD the sum of **Rs.10,000/- (Rupees Ten thousand only)** unto and upon the Trust and subject to the powers and provisions hereinafter declared and expressed of and concerning the same.

2. **NAME OF THE TRUST:**

The Trust shall be named "**ALL INDIA YOUTH COMPUTER SAKSHARTA MISSION**" (HEREINAFTER REFERRED TO AS "THE TRUST") or to be known and referred to shortly as "**AIYCSM**" Trust; which is also identical and same. The Trustees may if they so desire change the name of the Trust in future.

3. **REGISTERED OFFICE OF THE TRUST:**

The Registered office of the Trust shall be situated at **Station Approach Road, P.O. Krishnanagar, P.S. Kotwali, Dist: Nadia, Pin: 741101, West Bengal, India,** or at such other places as the Trustees may from time to time determine.

4. **OBJECTS OF THE TRUST:**

- a. The Trust shall be an irrevocable public, educational & cultural Charitable Trust without any object of profit making and shall operate/ render services throughout India regardless of caste, colour or creed.
- b. To promote education culture and arts of all kinds necessary training to the students/children and youths.
- c. To provide equal opportunities for education to people from all strata of the society by providing concessions, scholarships and assistance to children from poor, needy and deserving families.
- d. To provide self-employment opportunity to unemployed under its I.T. educational and occupational training awareness programme through Open/Setup/Startup Computer Education Affiliation, Computer Centre Affiliation, Computer Institute Affiliation, Computer Affiliation, Computer Education Franchise, Computer Institute Franchise and Computer Centre Franchise in India.
- e. To eliminate at great extend prevailing problem of unemployment by providing 100% job oriented computer education/vocational education training so that strength of nation can be engaged in service and self-employment.

- f. To conduct campaign, training programmes, seminars, symposia etc. and to participate in them either in or outside India.
- g. To acquire land in the name of the trust in order to open, found, establish, support and maintain Schools, Colleges, Institutions and to grant certificates, diplomas and degrees of the Trust.
- h. To establish and maintain of vocational, professional training institution for the handicapped students with the consent of concerned authorities.
- i. To provide scholarship and other incentives to desirous students/persons.
- j. To conduct various diplomas, computer courses and granting them certificate on various software.
- k. To provide all kind of Academic, Technical & management education & Franchisee management.
- l. To Starts, Computer Teachers' Training, Computer Software, Computer Hardware & Network Engineering, Fashion Designing, Animation, Management Courses.
- m. To carry out other and purposes, that may be conducive to and beneficial for the members to fulfill the broad objectives of the of our work is primarily to investigate computer mediated disaster communication system using rapidly deployable mobile computing and wireless communication technology Information Network.
- n. To develop, design, setup and operate nationwide state-of-the-art computer communication infrastructure with international connectivity directed towards research and development, advancement of high quality education, create and host content, express creative and academic potential via Intranet and Internet, peer to peer connectivity among educational and research institutions in the country and the world and make available the communication infrastructure to users in academic, research and development institutions, Govt. organizations in line with national priorities.
- o. To act as a research centre for technological and managerial resources and also act as a bridge for cooperation among other countries in the area of computer communication information technology, computer networking and other related emerging technologies.
- p. To invest the Trust Fund either in the purpose of mortgage of immovable property or in shares, stock or debentures or other securities and investments, or in deposits with or loans to any company, bank, firm or any other person, and to alter, vary or transpose such investments, from time to time at the discretion of the trustees.

- q. To make as well as to change or amend memorandum of Trust [Aims & Objects] and rules and regulation for the conduct of business of the Trust.
- r. To do such other acts as are incidental or conducive to the attainment of any or all of the above mention objects.

IT BEING EXPRESSLY DECLARED THAT if any or one or more of the objects specified in this clause are held not being objects of public charitable purpose as defined by the Income Tax Act or statutory modifications thereof the trustee shall not carry out such objects, but the validity of the Trust created by those presents as trust for Public Charitable purpose shall not in any way be affected.

- A. It shall be lawful for the Trustees to receive by way of gifts, grants, bequest, donations, contribution, movable and immovable properties and legacies from any persons, firms, associations, trusts, cooperative or Government/ Semi Government bodies, authorities, undertakings or establishments whether towards corpus of the Trust in accordance with the provisions herein contained. However, all investments made or retained by the Trust shall be in accordance with the provisions or Income Tax Act 1961.
- B. The trustee shall have power by supplementary declaration(s) resolution(s) of the Board to amend, delete or alter any of the objects set out hereinabove or any matter provided in the Deed as may be determined by two third majority of the Trustees and/or to the extent such amendments, declarations or deletions be required by the Commissioner of Income Tax or any other competent tax authority in order that the Trust be eligible and continue to eligible for the various exemptions and privileges granted to Public Charitable Trusts under the Income Tax Act, 1961 and/or under any other Indian Tax Statutes for the time being in force.
- C. That in case any of the objects of the Trust are held to be non-charitable within the meaning of section 2 (15) of the Indian Trust Act, or any statutory modification (s) thereof, the Trustee (s) shall not carry out such objectives.

5. TRUSTEES:

The Board of Trustees shall comprise of not less than **2 (Two)** and not more than **11 (Eleven)** Trustees. However the maximum number of Trustees may be increased by the Trustees for the time being in force and also constituting two third majority of the board of Trustees. The following shall be the first Trustees:

1. **Sri Santanu Das**
2. **Sri Subodh Chandra Das**

6. TENURE OF TRUSTEESHIP

The Chairman shall a trustee of these present be and have the privileges of the Chief Executive Officer of the Board of Trustees for lifelong. The remaining Trustees whenever appointed under these presents shall hold office for 3 (Three) years. After expiry of the said period of 3 (three) years from the date of the appointment of such Trustee(s) s/he will automatically cease to be a trustee. However, they shall be eligible to be re-appointed as many times as the other Trustees by majority voting appoint them as such.

7. VACANCIES IN THE BOARD OF TRUSTEES/FILLING UP OF VACANCIES:

Vacancies in the Board of Trustees may occur due to the following reasons:

- (i) Resignation or,
- (ii) Death or,
- (iii) Conviction of Criminal Offence involving moral turpitude, or
- (iv) Desiring to be discharged or refused or become unfit or incapable to act as a Trustee or to execute the duties and to execute powers reposed in him under these presents, or
- (v) Adjudged insolvent or declared bankrupt or lunatic or becomes of unsound mind, or
- (vi) Goes out of India for more than 6 (six) months without obtaining the permission in writing from the Chairman or,
- (vii) Remains absent from 4 (four) consecutive meetings, of the Board of trustees without obtaining the permission in writing from the President to that effect or,
- (viii) Expiry of tenure in terms of this Trust Deed or,
- (ix) If a request is made in writing to a Trustee to retire by all the other Trustees for the time being in office and also constituting the majority of the Board.

8. CONSENT OF NEW TRUSTEES

Every new Trustee or Trustees to be appointed as aforesaid shall have the same powers, authority and discretion and shall in all respects act and be liable as if he/she had been originally appointed as a trustee under these presents. **PROVIDED** that he/she shall not be entitled to act as trustee under these presents until he/she shall have given a letter of consent to the Trust to act as such Trustee under these presents.

9. MEETING OF THE BOARD OF TRUSTEES:

- (a) The Chairman shall during his life so long he shall remain a Trustee of these presents be and have the privilege of Chairman of any meeting of the Trustees as aforesaid at which he shall be present including the right to a casting vote in case of an equality of votes arising at such meeting.
- (b) The Trustees shall hold Ordinary meetings at least twice in each year. A special Meeting may at any time be summoned by any Trustee.
- (c) The Trustee may from time to time appoint secretary and fix his remuneration.
- (d) The Trustees shall keep or cause to be kept a Minute Book of their proceedings and proper books of account and all provisions of the law (if any) in relation to the accounts of the trusts of these presents shall be duly observed.
- (e) Subject to these provision and to the rules of the trusts of these presents the Trustees may from time make regulations as to their meetings and the conduct of their business and otherwise as to the management of the trusts of these presents.

- (f) Any resolution of the Board of Trustees circulated to all the Trustees, who may be in India and approved by at least two-third of them shall be valid and effectual as if it had been passed at a meeting of the Board of trustees.

10. QUORUM:

- (A) There shall be quorum when at least 1/3 rd of the number of trustees for the time being are present at any of the meetings. Pending any vacancies the Trustees for the time being in less number than the quorum may validly act only for the purpose mentioned hereunder in Clause 10(B)
- (B) If and whenever the number of Trusts has reached below 2 (Two), the continuing Trustees shall appoint new Trustee(s) so as to make up the total number of Trustees for the time being to not less than 2 (Two)

11. NOTICE OF MEETING

Any notice of meeting or for any other purposes required to be given to a Trustee under these presents shall be sent through courier or by speed post or by registered post to each Trustee at his/her address mentioned hereinabove. Notice shall be deemed to have been received by the addressee on the expiry of 7(Seven) days from the date of its delivery in case of courier/speed post and 10(Ten) days from the date of its delivery to the post office in case or registered post.

12. REGISTER OF MOVABLE AND IMMOVEABLE PROPERTIES

The Trustee shall maintain a register of moveable and immoveable properties and assets of the Trust and shall keep it up to date by making additions to or alterations in the same if and when the properties or assets are purchase or disposed of by the Trustees and the Trustees shall physically verify the entries in such Register as least once in every year and initial the same with date.

13. TRUST FUND:

The Trustees shall irrevocably hold and stand possessed of the said monies all of which are hereinafter for brevity's sake referred to as the Trust Fund or Corpus which expression shall also include cash and other properties and assets moveable or immoveable and investments and deposits of any kind whatsoever into which the same or any part thereof may be converted, invested or varied from time to time or such as may be acquired by the Trustee or come to their hands by virtue of these presents and as donations, bequests, endowments, grants or by operation of law or otherwise howsoever in relation to their presents upon the trusts and with and subject to the powers provisions, amendments and declarations hereinafter declared and contained of and concerning the same. And it is hereby declared that this is an irrevocable Trust.

14. ENGAGEMENT TEAM OF EMPLOYEE/SERVICE PROVIDERS:

A. The Board of Trustees shall appoint Secretary(ies), Manager(s), Accountant(s), Clerk(s), Agents(s) and other servants(s) or employee(s) or consultants or services providers as may be required for the setting up the Trust on such terms and conditions as to fees, salary, wages, dearness allowance etc. and the office of the Trustees will normally be honorary but the Trustees will be entitled to be paid their actual travelling expenses and other incidental charges incurred by them in attending the meetings and in connection with carrying out the objects of the Trust.

15. POWERS OF TRUSTEES:

The Board of Trustees shall, inter alia, have the following powers

- (a) The Trustees shall at all times be vested with the ownership, control, management superintendence and supervision of the Trust and shall be entitled to exercise all powers required for the purpose of running and operating the same within the limits of the funds from time to time and for the time being at their disposal.
- (b) Chairman-Cum-Chief Executive Officer of the Trust is delegated the authority of scrutinizing all financial and legal documents of the Trust.
- (c) Any of the Trustees may by power of attorney or other legal instrument authorized his co-trustee or any of them on his behalf to exercise the power or to do any act whatever in relation to the trusts hereof.
- (d) The Trustee may manage all the lands and buildings whether of freehold or leasehold tenure which shall for the time being be held by the Trustees upon the trust of these presents with all the powers in that behalf as absolute owners including power to sell, assign, let, mortgage, hypothecation, exchange or otherwise deal with any land or building and to erect pull down rebuild add to and repair houses and buildings.
- (e) To expand and/or invest the funds of the Trust in such manner as they shall in their absolute discretion consider most beneficial for the Trust (including investment in Securities, fixed and other deposits, moveable or immoveable properties and any other category or investments as may be permitted by Section 11(5) of the Income Tax Act, 1961.
- (f) To acquire /discharge in the name of Trust or the Board of Trustees, build upon ,pull down, re-build, add to, alter, improve, sell, let-out or rent, exchange or sell/dispose of, or mortgage, hypothecation or otherwise deal with any such land and/or buildings or premises for the purposes of Trust or for making further investments as provided herein.
- (g) To purchase, hold, sell or mortgage any kind of properties/equipment and assets for the purposes of Trust or by way of investments.
- (h) To enter into contracts/agreements/arrangements etc. authorized by these presents, on behalf of the trust and to secure the fulfillment of any such contracts/agreements/arrangements.
- (i) To borrow, for the purpose, authorized by these presents, monies upon security of any of the properties of the Trust and grant or direct to be granted mortgages for securing the same.
- (j) To pay all premiums, revenues, rents, Municipal rates & taxes other charges and outgoing payable in respect of the Trust properties.
- (k) All decisions of the Board of Trustees shall be taken by a resolution of the members of the Trust. Resolutions shall be deemed to have been passed when approved by a majority of the members of the Board of Trustees. The Chairman has a second or casting vote in case voting results remain a tie.

16. LIABILITIES OF TRUSTEES:

The Trustee shall be respectively chargeable only for such monies, stocks, funds, securities and other property as they shall respectively actually receive notwithstanding their respectively signing any receipts or cheques for the sake of conformity and shall not be answerable or responsible for the acts, receipts, omissions, neglects and defaults of any bankers, broker, auctioneer or other persons within whom or into whose hands any trust monies or securities may be deposited or for any other loss unless the same shall happen through their own negligence, willful default or omission or breach of trust, misapplication or misconduct.

17. REIMBURSEMENT OF EXPENSES:

The Trustee (s) of these presents for the time being may reimburse themselves, him or herself and pay and discharge out of the funds or monies in their hands all the expenses incurred in or about the execution of the Trust or the Powers of these presents. The Trustee may also be paid actual traveling expenses for participating in meetings of the Trust.

18. MANAGEMENT:

(a) The trust shall, wholly at its discretion, enter into such agreement for transfer of the management, control and administration of the trust as may be decided by the Trustees from time to time.

(b) The Trustees may lay down any policies and discretions but shall not be responsible for any acts or defaults of such charitable trust, society, association or institution.

19. POWER TO FRAME RULES:

The Board of Trustees may from time to time prescribe further rules and bye-laws for the governance of the Trust and any of the institutions as it may establish pursuant to these presents and as to the meetings of the Trustees the mode of convening the same and the conduct of business thereof and otherwise as it may think fit and may also delegate any power and duties to any committee or committees or person or persons consisting of such of the Trustees and outsiders as they may appoint for such purposes and may at their discretion amend such rules and bye-laws.

20. SURPLUS INCOME:

The surplus and unapplied portion of the said income, if any, arising in any one or more year or years shall be accumulated by investing the same and the resulting income thereof from time to time to any of the investments in which the Trust funds and hereby directed or authorized to be invested and may be credited to an account to be called "**Revenue Accumulation Account**".

21. INVESTMENT:

Subject to the provisions of any law applicable in regard to investment of funds for the time being in force and applicable to this Trust the Trustees may invest the Trust Funds and every part thereof in any stocks, shares, securities, mutual funds, debentures, loans, deposits, in construction or purchase or mortgage of any immoveable properties and in any other investments as permitted by Section 11(5) OF THE Income Tax Act.

22. OFFICIAL LANGUAGE OF THE TRUST:

The official language of the Trust shall be English. However, when necessary other language may also be used in the management and administration of the Trust.

23. BOOKS OF ACCOUNTS:

- (A) The Board of Trustees shall cause to be kept and maintained proper books of accounts in respect to the sums or monies received and expended by the Trustees and all the matters in respect of which such receipts and expenses relate to and all the properties and assets for the time being vested in them and for all liabilities and obligations (existing or future) in connection therewith.
- (B) The Balance Sheet and Income and Expenditure account of the Trust shall be prepared and audited at least once in each financial year by a recognized firm of Chartered Accountant and placed before the Board of Trustees at a meeting to be held as far as possible not later than 6(six) months of the date up to which accounts have been made.

24. BANK ACCOUNT:

- (A) All accounts in the bank shall be maintained in the name of the Trust.
The Trust will open an account with a reputed Bank close to its registered office. Such account will be required to facilitate transactions of the Trust and for safe-keeping of overnight cash. This account will be operated jointly by Chairman and any one of the present Trustees.
- (B) The Trust will also open similar accounts of its branch offices, as and when established for addressing the objectives of the Trust. Such accounts shall be operated by any two persons jointly who have been nominated and authorized by the Board of Trustees by a resolution passed in this behalf.

25. FINANCIAL YEAR:

The financial year of the Trust shall be from 1st April to 31st March each Year.

26. AMENDMENT OF THE CONSTITUTION OF THE TRUST, DISSOLUTION AND MERGER:

- a. With a resolution of only 2/3rd majority of the Board of Trustees, the following matters shall be effective and the trustees shall have the power to do the following acts :
- i) Any clause of this Trust deed can be amended in so far it does not affect the main objects as well the spirit behind for conduct and management of the Trust.
 - ii) Any other Trust with similar object can be merged with this trust provided the merger does not affect the activities of this Trust financially or otherwise.
 - iii) If found to be not viable or impossible to manage the funds, properties and activities of this Trust can be merged with any other Trust, institution etc. So long as the main object of the other Trust is similar to this one.
 - iv) The Trust also can be dissolved and after meeting all of its liabilities, if any, the balance of properties, funds etc. Shall be transferred to another Trust, society and institution with similar objects.

27. IRREVOCABLE

The Trust constituted herein shall be irrevocable.


